State questions for the Nov. 8, 2016 Ballot

SQ 776: Adds to OK Constitution

Sec 9A of Article 2 - Death penalty may use other execution method if one is ruled invalid shall not constitute infliction of cruel or unusual punishment. If a method is ruled invalid, execution remains in force.

SQ 777: A Constitutional Amendment

Give Oklahoma residents the right to engage in farming and ranching practices and employ agricultural technology. The amendment bans any new law regulating or prohibiting an agricultural practice unless it can be shown to have a "compelling state interest." That means any new agricultural regulations would have to pass strict scrutiny, the legal standard used for laws that deprive people of fundamental rights like free speech, gun ownership, or religious freedom.

SQ 779: A Constitutional Amendment

Would Raise the state sales and use tax by one percentage point permanently generating 600 million. \$5000 raise to all teachers only comes to \$280 million. Where does the rest go??? State government will expand by adding new office for this tax.

Of the total revenue generated by the new tax, 60 percent would go to provide a salary increase of at least \$5,000 for every public school teacher. The remaining funds would be divided between public schools (9.5 percent), higher education (19.25 percent), career and technology education (3.25 percent), and early childhood education (8 percent). The State Board of Equalization would be required to certify revenues from the new tax are not being used to supplant existing funds.

(OCPA gave a simple method to increase salaries without any tax .)

SQ 780: Changes the classification of drug possession crimes from felony to misdemeanor. It also raises the dollar amount that determines whether property crimes are a felony or misdemeanor from \$500 to \$1,000 - (Can potentially increases crime due to lower penalty.)

Q 781: One Cent Tax Directs the cost savings from SQ 780 to a fund that would be distributed to counties to provide mental health and substance abuse services. The state Office of Management and Enterprise Services is directed to determine the annual savings, which will be distributed to counties in proportion to their population.

SQ 788: Legalizing the use, sale, & growth of Marijuana in Oklahoma

SQ 790: A Constitutional Amendment

Would repeal Article 2, Section 5 of the Oklahoma Constitution, which reads, "No public money or property shall ever be appropriated, applied, donated, or used, directly or indirectly, for the use, benefit, or support of any sect, church, denomination, or system of religion, or for the use, benefit, or support of any priest, preacher, minister, or other religious teacher or dignitary, or sectarian institution as such."

It was this section that was used to Remove the 10 Commandments in Oklahoma City, OK

SQ 792: A Oklahoma Constitutional Admendment

Allows grocery and convenience stores to sell 14% wine and high-point beer. Currently convenient & grocery stores are prohibited from selling beer containing above 3.2 percent alcohol by volume, as well as all wine and all liquor. To buy wine and liquor, one needs to go to a liquor store. SQ 792 if passed, will enable for up to 14% alcohol to be purchased in convenience stores, giving increased probability for underage teens to purchase and consume as well as .

(Tulsa & Broken Arrow already has 137 liquor stores. If SQ792 passes, It will add an additional 471 potential convenience stores and 271 potential grocery stores equaling 879 stores or more becoming liquor stores.)

SQ 792 would also allow Oklahoma liquor stores to sell refrigerated beer and alcohol accessories i.e., sodas, corkscrews *(Reason sold warm to deter from buying and getting into car drinking)*

The measure would allow multiple beer and wine stores to be owned by one corporation (ownership would be limited to two stores per person if spirits are sold). Currently individual liquor store owners are not allowed to have more than one store. If SQ 792 passes, these changes would take effect on October 1, 2018.

(Oklahoma is 4th in the nation with laws against drunken driving.)
