GOVERNOR

Republican Candidates:



KEVIN STITT, 49 Republican

Very Conservative

He is the incumbent Governor of Oklahoma, seeking 2nd term and Endorsed by President. Donald Trump, who had a fundraiser for him in Florida. He started January 14, 2019 with term ends on January 9, 2023. Stitt is a citizen of the Cherokee Nation and 2nd Native American to be elected as governor in the US. Stitt, a successful businessman, had founded and built a nationwide mortgage company, Gateway Mortgage. Stitt signed 3 Pro-Life bills, one has been called the toughest abortion law in America, stopping Abortion with a few exceptions. Stitt has been diversifying Oklahoma's economy and reformed medical care in the state. He stood up to the Indian tribes in renegotiating the gambling compact between the Indians and the state. Stitt was born on December 28, 1972, in Milton, Florida. He graduated from OSU in 1996 with a bachelor's degree in Accounting.



MARK SHERWOOD, 57 Republican

Conservative (Conditional)

Mark Sherwood was born in Tulsa, Oklahoma. Sherwood works as a naturopathic doctor. He earned a bachelor's degree from Phillips University in 1987 and a degree from Trinity School of Natural Health in 2014. and he lists election integrity, abolishing abortion, stopping Second Amendment infringement, ensuring "critical race theory" isn't taught in schools, banning mandatory vaccines, masks or lockdowns and the deregulation of business and agriculture as issues of focus on his campaign website. In September, Sherwood said he believes the 2020 election was "hijacked" and that Oklahomans should demand a forensic audit of the 2020 election results. "I looked at the status of the state and thought we need to make a change. There is a lack of accountability from the top and I think our constitutional rights have been violated. I think being a non-politician is exactly what we need."



JOEL KINTSEL, 46 Republican

Insufficient Information

An executive director of the Oklahoma Department of Veterans Affairs. Kintsel also is a lieutenant colonel in the Oklahoma Air National Guard and staff judge advocate of the 137th Special Operations Wing at Will Rogers Air National Guard Base in Oklahoma City.

He served as parliamentarian for 14 years under seven Oklahoma House speakers.

He grew up in Oilton and graduated from Cimarron Christian Academy there. He earned a bachelor's degree from Oklahoma State University and a law degree from the University of Oklahoma. Kintsel describes himself as a "Ronald Regan conservative" in a news release announcing his candidacy. He described the Stitt administration as "rife with corruption, self-dealing and cronyism and Oklahomans deserve another choice."



MOIRA McCABE, 40 Republican

Leans Conservative

Moira McCabe was born in New Orleans, Louisiana. Her career experience includes working as a homeschool parent, a welder, and a computer repair person. She has been affiliated with Oklahoma 2A, Children's Health Defense, Moms Demand 2A, and Oklahomans unified against abortion. Moira wants to promote more birth control claiming it will save taxpayers money and help with abortion. She wants to rein in Oklahoma Turnpike Authority due to mismanagement.

TODD RUSS, 61 Republican

Conservative

(ACU) Conservative 2021 – 78%, 2020 - 64%; Lifetime – 72%

OK Constitution Lifetime – 83%; OCPA Lifetime – 69%

He is a member of the Oklahoma House of Representatives, representing District 55. He assumed office on October 21, 2009. His current term ends on November 23, 2022.

Todd Russ has been in the Oklahoma House since 2009 and has more than 35 years of banking experience. He is the chairman of the House Appropriations and Budget Transportation Subcommittee. This year, Russ co-authored Senate Bill SB1503, which bans abortions after six weeks of pregnancy, but didn't vote at all on the important bill HJR1070 concerning new set of standards for Schools which

promote abortion, question conservative religious family values, and give teachers the right to give health care council they are not qualified for. He authored a bill 3702 requiring schools and kindergartens to have a full database of all the materials which are accessible for kids. That will protect children from inappropriate materials.



CLARK JOLLEY, 51 Republican

Leans Conservative

(ACU) Conservative 2016 – 80%; Lifetime – 77%

OK Constitution 2016 – 50%; Lifetime – 67%

Jolley was a member of the Oklahoma State Senate, representing District 41. He assumed office in 2004 and left office in 2016 by term-limit. Jolley previously served as assistant majority floor leader.

Jolley was a 2014 Republican candidate who sought election to the U.S. House to represent the 5th Congressional District of Oklahoma. He was defeated in the Republican primary on June 26, 2014.

Jolley earned his B.M.E. and B.A. in political science from Oklahoma Baptist University in 1992 and his J.D. from the University of Oklahoma College of Law in 1995. His professional experience includes working as an adjunct professor, running a private law practice and serving as an administrative law

judge for the Oklahoma Department of Labor.



DAVID B. HOOTEN, 59

Moderate

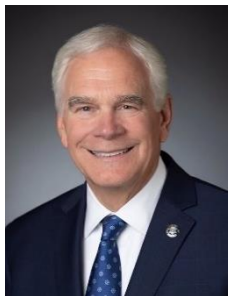
Changed from Democrat to Republican in 2014 to run for OK Senate.

Hooten was a 2014 Republican candidate for District 40 for OK State Senate. Previously ran as a Democrat for the House of Representatives in 2004, was stricken from the ballot due not meeting voter registration requirements. In 2016, Hooten beat Oklahoma County Clerk Carolyn Caudill and won re-election in 2020 as Oklahoma County Clerk. At City Council meeting Hooten proposed a \$25 million dollar proposal to train sniffing dogs for Covid-19, trained by handlers, asking to purchase 100 acres, for building and training. David Hooten was born in Frascati, Italy. He earned a Music bachelor's degree from North Texas State University in 1987 and a master's degree from OU in 1989. His career experience includes working as a professional trumpet player, composer, producer, and business owner. Currently has several investigations pending for misuse of government office employees time for

running his campaign and sexual harassment.

JOHN M. O'CONNOR, 67 **Republican** (Incumbent) **Verified Conservative**
National Right to Life is pleased to endorse John O'Connor

O'Connor was appointed as the state's attorney general by Gov. Kevin Stitt (R) to succeed Mike Hunter (R). He assumed office July 23, 202 with current term ending on January 9, 2023. President Donald Trump (R) nominated O'Connor for Federal Judge on April 10, 2018 [https://ballotpedia.org/John O%E2%80%99Connor \(Oklahoma\) - cite_note-nom-2](https://ballotpedia.org/John_O%E2%80%99Connor_(Oklahoma) - cite_note-nom-2) US District Courts for the Northern, Eastern, and Western Districts of OK. O'Connor's nomination was not confirmed before the conclusion of the 115th United States Congress, and he withdrew from consideration for re-nomination on April 12, 2019. Sen. Jim Inhofe (R) said, "While I understand John's decision to withdraw, I don't like it .. We are missing out on an opportunity to place a person of the highest integrity and competence on the federal bench to serve all Oklahomans." *Tulsa World*, A

strong Pro-life and constitutional lawyer, since taking office, AG O'Connor filed multiple suits against over-reaching government against Biden government and 5 lawsuits challenging vaccine mandates for federal contractors, private sector employees, and healthcare workers in Nov. 1, 2021. He stated Federal government does not have the power to "mandate" shots to anyone's body. They're sued Ascension Healthcare for denying religious exemptions to the vaccine and won. Oklahoma became one of the first states to sue over the vaccine mandate for the military and National Guard. "The reason for all five of our lawsuits really, is the rights and liberties belong to the individual in America, not government," said O'Connor. "That's different than many other nations in the world." O'Connor joined a multi-state border-crisis lawsuit against Biden Administration.

John O'Connor earned a bachelor's degree in political science from OSU and a law degree from the University of Tulsa. O'Connor's career experience includes his own law firm, and working as an attorney with the Hall Estill law firm. He served as President/director of Tulsa's Ronald McDonald House and as the President of the Rotary Club of Tulsa.



GENTNER F. DRUMMOND, 58 **Republican** **Moderate**

Drummond ran in 2018 election for Attorney General of Oklahoma and lost to Hunter. He is a highly decorated pilot in the Gulf War." Drummond currently is a majority owner of BlueSky **Bank** (locations in Tulsa's midtown and downtown, Cleveland and Pawhuska), **Bank** of Cushing, Drummond Communications, LLC (US cellular largest provider), Post Oak Lodge and Retreat, an Osage County cattle ranch, and a twelve lawyer firm. Mr. Drummond, a lawyer, has donated money to Joe Biden plus other Democrats, and is received money from Democrats. Drummond has given to 19 Democrat campaigns in past years. He appears pro-abortion through his giving to liberal candidates, such as Democrat in the Tulsa Mayor's office. He gave to both liberal Democrats in both U.S. Senate, and State Senate, Drummond received \$74,250 from democrat donors for his campaign by OCPA Article "Many of the overlapping donors made identical contributions to both Hofmeister and Drummond's campaigns." It was he had a conflict of interest in received millions for PPP loans for his businesses, but the problem is, he received some funds from the bank he personally owns major stock in. Another issue reported by The Oklahoman, a widow who claimed Drummond lied as attorney for ONB Bank, supporting the claim they had not paid their construction loan in full and tried to seize her life insurance from the death of her husband. A trial court awarded her \$2.25 million judgement, found that her loan was paid, and the court intervened and stopped seizure of the money. Drummond's law firm represents banking, business and employment clients, located in Tulsa.

STATE AUDITOR AND INSPECTOR

CINDY BYRD, 49 **Republican**

Conservative

She is the Oklahoma State Auditor and Inspector and running for re-election. She assumed office on January 1, 2019 and term ends on January 9, 2023. Byrd had an Accounting Degree in 1997 and received her CPA in 2003. Cindy Byrd has been on a campaign to eliminate government waste, fraud and abuse while making sure that local government runs as it should. She audited Epic Schools and found some discrepancies that led her to auditing Public Schools and Department of Public Instruction. It will be finished in two months.



STEVEN W. McQUILLEN, 65 **Republican** **Conservative (Conditional)**

McQuillen has served as the fixed asset accounting manager for the Tulsa Public Schools district since 1998. He master's in finance from Oklahoma Wesleyan University in 2016. From 2004 to 2006, he served as a volunteer auditor and treasurer of the Philippine American Association of North Eastern Oklahoma. Auditing and tax professional for 29 years. Owned and operated a bookkeeping and tax company. Lectured fixed asset accounting at Tulsa Public Schools and Oklahoma State University liaison for the "Open Records Act" concerning thousands of missing assets at out schools. Spokesperson for the district with the news agency's investigative reporting. Served as judge on "Tribunal" cases administering dismissals or penalties per district guidelines.

SUPERINTENDENT OF PUBLIC INSTRUCTION

RYAN WALTERS, 36 Republican

Conservative (Conditional)

Current Secretary of Education, was a History and Government teacher, as well as advance studies and was nominated as Teacher of the Year for the State in 2016. Ryan supports great change in education and expanding school Vouchers. Ryan is Chief Executive Officer of Every Kid Counts OK. Walters asked the Stillwater Public Schools to end a bathroom policy that allows students to use the bathrooms they wish instead of according to the God-given sex. Walters has supported O'Connor and Stitt's regarding HB 1775, which bans the teaching of Critical Race Theory in public schools.



JOHN COX, 58 Republican *Changed from Democrat to Republican.*

Moderate

John ran as Democrat last two elections, 2014 & 2018, for this office. He is Pro-Life. He is against Expanding School Vouchers; meaning money follows the student to the school of choice by parents. Vouchers make private schools an option to every student and creates an incentive to teach exceptionally, yet he is not for this. He believes school should not teach morals.



APRIL GRACE, 56 Republican Endorsed by Joy Hofmeister

Leans Liberal

Grace is a 30 year career educator, and April has in the past many acknowledgements of Excellence as a Leader. She is currently dealing with a scandal of a male teacher/coach under her supervision, admitting to sex with a 17 year old boy, plus accused of violating others, going back to 2007. Uncovered personnel documents show many reprimands, parent & student complaints, and suspensions without being fired. Grace and other district officials have been criticized after an SPS assistant athletic director was accused of sexual misconduct with a 17-year-old boy and investigators revealed that the man, Ron Arthur, had remained employed by Shawnee Public Schools despite receiving eight admonishments for other alleged verbal and sexual misconduct over the years.



WILLIAM E. CROZIER, 75 Republican

Insufficient Information

Guilty of Embezzlement

Crozier, of Union City, has tried for decades to win public office. He ran for U.S. Senate in 1984, losing to Democrat David Boren, and for state superintendent in 2006 in a failed challenge to longtime incumbent Sandy Garrett. He pleaded guilty in 2011 to felony embezzlement, online court records show. His sentence was deferred last year.

A retired veteran, previously ran for the office of state superintendent in 2006. Back then, he said that he wanted to make schools safer by creating bullet-proof textbooks. Crozier also ran for lieutenant governor in 2010, receiving only about 6% of the Republican primary vote.

SEAN ROBERTS, 48 Republican

Very Conservative

(ACU) Conservative – 83%; Lifetime – 86%

ACU rates Roberts as the 2nd most conservative Republican in the State House.

OK Constitution 2021 – 80%; Lifetime – 79%; Endorsed by Governor Kevin Stitt

Sean is a member of the Oklahoma House of Representatives, representing District 36. He assumed office on November 17, 2010. His current term ends on November 23, 2022.

Roberts earned his master's degree from the University of Oklahoma. His professional experience includes serving on the Hominy Chamber of Commerce. One of the few republicans who voted **against** the bill HJR1070 concerning new set of standards for Schools which promote abortion, question conservative religious family values, and give teachers the right to give health care council they are not qualified for.



KEITH SWINTON, 58 Republican

Leans Conservative

Keith ran for Labor Commissioner in 2018, but he lost in the Republican primary. For three decades he worked for the United States Postal Service's National Center for Employee Development. He is a mechanical engineer and inventor, and currently works as a project engineer for Ready Services, LLC. Keith believes Taxpayers should fund education thru college, yet many colleges have huge endowments and promote liberal left agendas.



LESLIE KATHRYN OSBORN, 58 Republican

Liberal

(ACU) Conservative 2018 – 61%; Lifetime – 61%

OK Constitution 2018 – 21%; Lifetime – 48%

Leslie is the incumbent Oklahoma Commissioner of Labor on January 14, 2019, term ends on January 9, 2023. Osborn is a former Republican member of the Oklahoma House of Representatives, representing District 47 from 2008 to 2018. Her performance in the House was extremely low, actually more liberal. She didn't VOTE for multiple key conservative votes! [She missed 25 VOTES in 2017-2018](#) alone, thus not representing OK people in her district, showing disinterest in her position and people.

TODD THOMSEN, 54 **Republican**

Lean Conservative

OK Constitution 2018 – 42%; Lifetime – 55%
(ACU) Conservative 2018 – 61%; Lifetime – 57%

He is a former Republican member of the Oklahoma House of Representatives, representing District 25 from 2006 to 2018. He contended for Creation to be put in the schools. He previously served as assistant majority floor leader. After leaving the Legislature, he was managing director of community relations for Epic Charter Schools.

Thomsen was unable to run for re-election in 2018 to the Oklahoma House of Representatives because of term limits. He played OU and on one of their national teams.



KIM DAVID, 61 **Republican**

Moderate

(ACU) Conservative 2021 – 84%; Lifetime – 75%
OK Constitution 2021 – 80%; Lifetime Score – 62%

She is a member of the Oklahoma State Senate, representing District 18 starting in 2010-2022. David served as state Senate majority leader from 2019 to 2021.

David earned her B.S. from Oklahoma State University in 1984. Her professional experience includes working as a small business owner in the property management industry. David is term limited. She owns a small business in Porter. She supported Stitt's reforms concerning Medicaid.



HAROLD D SPRADLING, 87 **Republican**

Moderate

Pastor, teacher and counselor. With a B.S. in Law Enforcement received the Masters in Education. Licensed as a LPC Licensed Professional Counselor LPC and a Licensed Alcohol and Drug Counsel LADC. Worked in a mental institution as a Psychiatric Social Worker, served as School Counselor at two public schools and one alternative school. Also received ministerial credentials at age twenty three and continue as a retired ordained minister. For fourteen years served as Director of a residential treatment program until retirement, June 1, 2018. Spradling has run unsuccessfully for Corporation Commissioner twice before. He lost to Commissioner Bob Anthony and Commissioner Todd Hiett.



JUSTIN HORNBACK, 38 **Republican**

Insufficient Information

He is from Broken Arrow and is a representative for the Pipeliners Union 798 in Tulsa. He has also worked as a welder and is a certified welding inspector and safety and health specialist.

"I have made my career working in the Oil and Gas industry working with industry leaders building infrastructure to deliver the products we all use to fuel our lives. I have worked on and off the right of way to provide for my family. I am no stranger to hard work and long hours, working in the office or in the field to get projects completed."

UNITED STATES SENATOR (Special Election)

Republican Candidates:



NATHAN DAHM, 39 **Republican** **Certified Very Conservative**
(ACU) Conservative 2021 – 100%; Lifetime – 95.4%
OK Constitution 2021 – 100%; Lifetime – 99%
OCPA Lifetime score – 100%

He is an Oklahoma State Senator, from 2012 – 2022 representing District 33, his current term ends on November 20, 2024. Just recently, Nathan filed two floor substitutes to protect Oklahoma children from sexualization and unnecessary “gender reassignment” surgeries.

He has passed over 100 bills all focused on protecting the rights of the people as well as repealing over 200 laws in order to reduce the size and scope of government. Nathan spent many years as a missionary in the country of Romania, seeing first hand the horrible effects of communist and socialism brings to a country, returning to the US, see the same methods and policies the Radical Left is trying

inflict on the U.S. Nathan currently is self-employed with his own app development company, and helps manage the cleaning company his family owns. Mullin is running in a special election to the U.S. Senate to represent Oklahoma. Mullin is a member of the Cherokee Nation and one of four Native American members of the 116th Congress. Based on analysis of multiple outside rankings, Mullin is a more moderate of center Republican Party vote.

He has the long list of “other” donors, including Tyson, Pfizer, Google, Microsoft, and JP Morgan Chase

all of which are WOKE. **Pfizer gave about \$55,000 in 2021. He Voted YES to Channeling Billions of taxpayers dollars overseas to create “Global Health Security Act” RC88 (HR391)** (a duplicate of WHO, UN initiatives of far extreme left concern Health shutdown). **Voted YES for \$50 Billion Dollar NEW spending for “Climate Change”** another far-left agenda. **Voted YES to providing DOJ with NEW over-reaching authority using a newly created “COVID-19 HATE CRIMES BILL.”** This is disturbing! **Voted YES taking on off automatic spending cuts** placed under 2011 Budget Control Act, known as the Sequester, one of the last hopes for fiscal responsibility (RC98 HR1868). Shannon was an Oklahoma House of Representative, District 62, starting in 2006-2014 to run for U.S. Senate vacant by Tom Coburn (R) retirement and lost. Republican primary June 24, 2014.

T.W. name is listed on McGirt Case among attorneys for the Indian Tribe defending a convicted Violent Rapist of a 4yr old child, Jimcy McGirt vs Oklahoma for the tribes against Oklahoma. The US Supreme Court reversed his conviction due to claim crime was done on Indian land and OK court had no jurisdiction. He was hired by the Senate in Sept 22, 2020 to help with redistricting the state as their Public Liaison. He was to be paid \$6,250 on a month to month contract. Shannon is President and Chief Executive Officer of Chickasaw Bank owned by the Chickasaw Nation in OKC. Shannon earned his B.A. from Cameron University and Law Degree from OSU



ALEX GRAY, 32 **Republican** **Leans Conservative**

Gray served as the chief of staff to the National Security Council during the Trump administration, according to his website. Gray is a Stillwater native who attended OK State University and George Washington University. He worked in Washington University. Alex Gray has a lot of endorsements from people in power. He is pro energy and security. He says we need a Trump Representative and not a career politician then he says we need someone like himself who is not a politician.



LUKE HOLLAND, 35 **Republican** **Moderate**

Holland has been endorsed by Inhofe TV ads, Holland is a Bartlesville native and currently resides in Bixby. Luke earned a degree in Finance from Walton School of Business of the University of Arkansas. FB post Sharing what it means to Restore Freedoms & Christian values.

Website indicates supports Trump agenda & fiscal Conservative.

Adam Holley was able to answer up to 6 questions on the "I-Voter" questionnaire and completed the Ballotpedia questionnaire. He has some good ideas; cutting government spending and only making investment that return revenue. Government should stop taxing paid off homes and not selling homes for unpaid taxes.

SCOTT PRUITT, 53 Republican

Leans Conservative

He is the former administrator of the Environmental Protection Agency (EPA). He was the 14th person to serve in the position. As EPA administrator, Pruitt was responsible for shaping federal environmental policy under the Trump administration. On July 5, 2018, President Donald Trump announced that he had accepted Pruitt's resignation, effective July 6, 2018. Pruitt served as the 17th attorney general of Oklahoma from January 2011 to February 2017.

After working for five years in the private sector, Pruitt entered the Oklahoma political stage in 1998 when he was elected to the state senate, representing Tulsa and Wagoner Counties. After two years, he was selected by his peers to serve as the Republican whip from 2001 to 2003 before being named the Republican assistant floor leader, a position he held until he left the state legislature. He then served as attorney general of Oklahoma from January 2011 to February 2017. In addition to his legal and political career, Pruitt became the general managing partner for Oklahoma City's triple-A baseball team, the Oklahoma Red Hawks, in 2003.



PAUL ROYSE, 51 Republican

Moderate

Was in 2020 listed as a candidate for house district 78 on the CAIR OK website. CAIR OK is a Liberal Organization, but does have reviews on candidates. CAIR Oklahoma's vision is to be a leading advocate for justice and mutual understanding. "Our mission is to enhance understanding of Islam, protect civil rights, promote justice, and empower American Muslims."

While his website reads conservative/Christian, there just isn't enough verifiable information to make an informed decision for accurate rating.

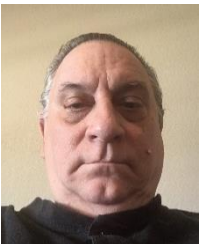


RANDY J GRELLNER, 56 Republican

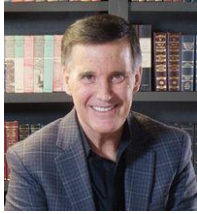

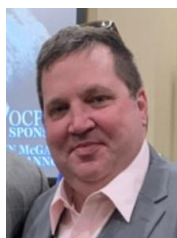

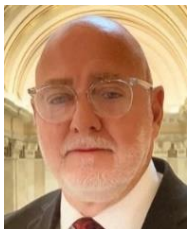
